Southern Association of Colleges and Schools Commission on Colleges
(SACSCOC)

Why?

- Make sure that Longwood and its programs meet or exceed the same standards as other regionally accredited institutions
- Ensure access to federal funding such as student financial aid and Pell Grants
- To take stock of what we do well and to look for areas where we can do even better.

Reaffirmation process covers areas which include:

- Student Achievement
- Institutional Planning and Effectiveness
- Administration and Organization
- Financial and Physical Resources
- Faculty
- Educational Program Structure and Content
- Academic and Student Support Services.

Reaffirmation of Accreditation

Two parts: Compliance Certification and Quality Enhancement Plan (QEP) Development

Compliance Certification:

- 2021-2022: Data Collection and First Draft
- 2022-2023: Data Refinement and Revised Drafts.
- Submission: September 2023.
- Onsite visit: Spring 2024.

Quality Enhancement Plan

Institutional Planning and Effectiveness

Standard 7.2

The institution has a Quality Enhancement Plan that (a) has a **topic identified** through its **ongoing, comprehensive planning and evaluation processes**; (b) has **broad-based support** of institutional constituencies; (c) focuses on **improving specific student learning outcomes and/or student success**; (d) **commits resources** to initiate, implement, and complete the QEP; and (e) includes a **plan to assess** achievement.

Five-year plan to enhance student learning and/or success by focusing on a specific topic

Considerations in Topic Selection

- Focused on undergraduate student learning and/or success
- Broad-based involvement of institutional constituencies including faculty, staff, and students
- Reflective of institutional needs and aligned with strategic priorities
- Potential impact = both (depth) and reach (breadth)
- Feasibility (resources, expertise, assessable)

Quality Enhancement Plan (QEP) Topic Recommendation Committee is broadly representative of the Longwood University community. This committee includes representatives from the three academic colleges, the student body, and staff.

The committee's responsibilities are to:

- inform members of Longwood community about the SACSCOC QEP requirements and Longwood's QEP topic recommendation process and timeline,
- identify possible QEP topics in the context of relevant university data and strategic priorities,
- facilitate discussions with campus constituencies and gather campus input about identified possible topics,
- evaluate the possible topics based on research, gathered feedback, and feasibility to fund and assess topics, and
- make QEP topic recommendations to Longwood's Reaffirmation Leadership Team, who will select the official topic.

Timeline: Topic Recommendation

August 2021

- Announce QEP Process to faculty and staff.
- Committee convenes for first meeting.

September – October 2021

- Announce QEP Process to students.
- Solicit topic ideas.
- Begin initial research and data collection to identify a “long list” of possible topics.

October – November 2021

- Conduct focus group discussions and surveys with institutional constituencies (faculty, staff, administration, & students) and relevant University Planning Council (UPC) subcommittees to present initial list.
- Use input to refine list.

December 2021 – Early January 2022

- Review research and gathered feedback to develop a “short list” of possible topics.

Timeline: Topic Recommendation

Mid-January – mid-February

- Provide campus-wide updates.
- Gather additional feedback, makes final adjustments, and evaluates support for list of possible topics.

Late February 2022

- Committee chair presents recommended topic list to the Reaffirmation Leadership Team.

Mid-March 2022

- Reaffirmation Leadership Team selects the QEP topic.
- QEP Topic Recommendation Committee service ends.

March 24, 2022

- Committee Chair presents the QEP topic to campus constituencies and discusses the QEP development and writing process.

April 2022

- Committee Chair presents the QEP topic to the UPC and discusses the QEP development and writing process.

Summer 2022-May 2023

- QEP Development and Writing

Fall 2023

- Submission of QEP to SACSCOC

Spring 2024

- QEP Presentation at SACSCOC On-Site Visit

Summer 2024 – Summer 2029

- Refinement and Implementation
