Faculty Senate Finance and Planning Committee Year-End Report – 4/26/18 Meeting

AAUP Budget & Planning Forum – Recap & Recording

The committee thanks Dr. Bill Abrams and Longwood's representatives of the Virginia Conference of the American Association of University Professors (AAUP) for hosting their annual spring forum, held on Feb. 20. Our committee assisted in co-sponsoring and planning the event, and recognizes President Reveley, Dr. Lara Fergeson and Mr. Ken Copeland for presenting and addressing questions. An estimated 84 people were in attendance and topics ranged from Academic Affairs budgeting, salary increases/compression, tuition revenue shortfall, spending of auxiliary reserves, Moody's bond issuer rating downgrading & many others. The forum lasted just over 90 minutes and was audio recorded, with a file submitted for Senate record & <u>hosted online publicly via SoundCloud</u>.

Our committee collected anonymous participant feedback immediately after the forum with 55 total respondents, 45 self-reported as faculty, 6 as staff, and 4 as administrative professionals.

The information was presented in an organized, balanced manner that left enough time for questions.

Qualitative responses were also collected regarding broad suggestions for these forums and specific budget topics to address. Our committee will use these to direct future programming. We invite faculty to continue to share concerns, recommendations and questions.

Updated Admissions Figures

Acknowledging the fall semester deposit deadline for first-year students is May 1, this report's listed numbers are as of Thursday, 4/12, and provided by Vice President Kindon. Applications for fall 2018 enrollment totaled 6,360, up from last year (6,065 reported on 4/27/17) and, for context, 50 percent higher than in 2013 (4,222). Administration reports 626 deposits for the first-year class, with a target of 1,150 by May 10 and an expectation for a class size of 1,090 by the first day of classes in August. Vice President Kindon stated she would be happy to provide Senate with updated figures after mailed deposits have been counted.

University Planning Council – Finance Subcommittee & UPC Meeting Takeaways

Our Senate committee works in conjunction with the <u>University Planning Council</u> (UPC), with each of us additionally serving as members of the UPC's Finance Subcommittee. The subcommittee met on Monday, April 9 & the UPC as a whole met on Thursday, April 12. The following are some key takeaways from these meetings related to the Finance Subcomittee.

During 4/9 subcommittee meeting:

- Dr. Power-deFur asked if Academic Affairs was considering a new budgeting strategy to better serve academic departments, Dr. Fergeson said budgeting for fiscal year 2019 was already largely complete, but stated funding departmental budgets by increasing the amount of front-end loaded monies through predicting intersession revenue, thereby providing more funding at the beginning of the academic year, was a priority for fiscal year 2020.
- President Reveley and Mr. Copeland stated they expected the General Assembly to approve funding for the upcoming fiscal year for Longwood with numbers comparable to the current year, likely with a slight increase. They also stated they were unsure if the General Assembly would again vote for a mandatory salary increase for all higher education institutions.
- Dr. Fergeson discussed funding of all Civitae-driven initiatives, noting all added positions have been fully funded and identified as priorities by the Board of Visitors. There are three new positions for fiscal year 2019, with two already hired, and an additional three positions to be added for fiscal year 2020.
- President Reveley and Mr. Copeland discussed plans to work with Human Resources during the next fiscal year to proactively identify current and future issues related to salary compensation and compression within academic departments. • Following up on points discussed during the AAUP Budget Forum of 2/20, President Reveley and Dr. Fergeson stated they planned to more closely examine models of tuition (by credit hour or by semester) during the upcoming academic year.

During 4/12 UPC meeting:

- President Reveley stated philanthropic gifts totaled around \$8 million with more expected before the end of the academic year. Mr. Copeland and President Reveley discussed focusing on working with and training department chairs and administrative assistants in an effort to better communicate just how these monies can be distributed.
- President Reveley provided updated Admissions numbers while also briefly recognizing the impact of decreased community college enrollment across the state.
- President Reveley briefly discussed ongoing and future construction projects, while stating feasibility studies were planned to explore the possible addition of a performance hall, as well as a convocation center, on campus.

The next UPC meeting will be held in October.
