Students Graduate students who are in good academic standing with the university, have three (3) or fewer academic credits or one course remaining registered for courses which, if successfully completed, will allow them to graduate by the completion end of their degree, and have enrolled in the courses required for graduation for the subsequent summer and/or fall academic semesters terms, and have received approval from the graduate coordinator of their program and the registrar shall be permitted to may participate in the graduation May commencement ceremony of that calendar year. Each Exceptions to this policy must be approved by the applicable graduate program may design requirements to allow students directors.
