Accreditation and Compliance, and the University Registrar collaborated on an updated and more efficient process to encourage the enrollment or transfer of veterans and military personnel (both active duty and Reserve/National Guard) by acknowledging the relevance of residential training they received as part of their military service.

This policy coincides with SCHEV's efforts to encourage and facilitate veterans' and military students' transition into higher education.

The current catalog language for veterans only applies to General Education Goal 11, which is now out-of-date. New policy language will allow for a clearer review of credit for veterans' educational training experiences.

The proposed revisions would allow a more efficient process in two ways. First, the registrar's office will review the student's Joint Services Transcript and compare it to the American Council on Education's *Guide to the Evaluation of Educational Experiences in the Armed Services* to ascertain whether there are any equivalent Longwood credits for the student's non-correspondence service schools. The registrar's office will make a recommendation to a representative from the academic department responsible for those credits.

Second, if those credits are approved, that equivalency will be noted for future transfers (unless either the military training or the Longwood class changes) in order to prevent redundant requests and to provide more clarity for potential students on what and how many transfer credits they can expect to receive. This is the process similar to evaluation of transfer credit from accredited institutions.

RATIONALE
