- b. Other corrections and modifications to the Time Tables are proposed so that procedures are made more clear and consistent.

No real changes to policy are proposed. Proposal includes:

1. Promotion Review and Tenure Review:

To the Promotion Review and Tenure Review time tables (FPPM pages 204-206, 210-212): the proposal adds the deadline for President's recommendation (see FPPM page 219 Procedures for Promotion and page 225 Procedures for Tenure), and adds a BoV appeals process (FPPM pages 166, 171). (page 3 and pages 13-14 of the proposal).

2. Proposal separates the Time Table for Probationary Review of Tenure Track Faculty, Lecturers and Clinical Educators (FPPM p. 206-208) into two separate Time Tables to make the process more clear (pages 4-8 of the proposal):

Time Table for Probationary Review of Tenure Track Faculty <u>in their Second Through Fifth Years of</u> <u>Employment,</u> and Lecturers and Clinical Educators <u>in their First Semester</u>

and

<u>Time Table for Probationary Review of Tenure-track faculty in their first year and lecturers and</u> <u>clinical educators in their second through fifth years of employment</u> **3.** To both of the new proposed Probationary Review time tables (FPPM pages 206-208) the proposal adds the appeals process regarding recommendation of terminating contact that was approved by the April 28, 2011 Faculty Senate vote but never entered into the FPPM (pages 4-8 of the proposal).
