A proposed change in the name and university status of The Bookstore Advisory Committee.

<u>BACKGROUND</u> (Provide a brief statement describing the origins of this proposal, the nature of the problem it addresses, and the work completed to devise the proposal):

The Bookstore Advisory Committee has existed as an informal committee—composed of Longwood faculty and staff and bookstore officials—for many years now, and while its members have worked to define the committee's consistent purpose, its primary aims have changed from year to year. Originally, the committee was appointed by members of the Executive Committee of Faculty Senate to enable its members to serve as liaisons between Longwood's faculty and staff members and the university's bookstore manager(s) and staff concerning suggestions for, questions about, and / or problems with both textbook and trade book orders. Unfortunately, this goal has not been consistently met due to the fluctuating nature of the committee's leadership and purpose. In short, the committee lacks official guidelines and governance. This year, the committee convened early in the semester to address the ongoing problems stemming from these inconsistencies, and it was decided that making the committee a standing committee of the Faculty Senate would ensure proper reporting, consistency of mission, and official university recognition of and support for that mission.

The members of the Bookstore Advisory Committee propose that the committee's name be changed to The Longwood Bookstore Innovation Group (BIG) and that the status of the committee be changed from informal to that of a standing committee of the Faculty Senate.
