A. Department of Social Work and Communication Sciences and Disorders

1. CSDS 510: Course change, title and description. *Information item.*
2. CSDS 650: Course change, renumber to CSDS 570. *Information item.*
3. CSDS 512: Pediatric Dysphagia. New Course. *Approved.*
