No Academic Penalty Withdrawal Period (Free "W") (p. 6 of current catalog)

Students may withdraw from individual classes with a grade of "W" (not computed in the GPA) through **5pm** noon the 35th day of regularly scheduled classes. Residential students who fall below full-time status with such a withdrawal will be referred to the Vice President for Student Affairs for special permission to remain in the residence hall.

b. Change of Grade Estimate Policy:

Grade Estimates (p. 10 of current catalog)

During the regular session, grade estimates are available to all first-year students, upperclass students making a "D" or "F.", and students who are not making satisfactory academic progress (all students with a cumulative GPA less than 2.0). Estimate grades are due to the Office of Registration by 5pm noon on Monday of the sixth week of regularly scheduled classes and are available to students and advisors in myLongwood as soon as they are posted.

c. Adding a grade of CR credit:

Longwood University grants 2 hours of PHED 101 credit for military service. We currently post this with a grade of "P" for pass.

The student does not actually pass a course so this grade is misleading. To use a grade of "T" for transfer would indicate the credit was earned at another institution.

Neither grade accurately relates what is happening. A grade of "CR" credit would indicate that we are just granting the credit.
