Action Item:

- I. Graduate and Extended Studies
 - a. Policy proposal to make pass/not pass grading and continuous enrollment work more effectively, the Graduate Committee proposes adding the grade of "SP = Satisfactory Progress" as an effective solution. The grading would be:
 - P = Pass (hours earned and applied towards the degree/licensure)
 - SP = Satisfactory Progress (hours earned, but do not apply towards degree/licensure)
 - NP = Not Pass (hours not earned and do not apply towards degree/licensure)

This grading would only be applicable to graduate internship/practicum/clinical experience courses, collaborative research/teacher research courses, and thesis courses in which the student must be enrolled continuously until completion. Each course will have a minimum number of hours with a passing grade required.

The Degree Audit would only accept hours with a grade of "P" to meet requirements for completion. If a program decides not to switch to Pass/Not Pass grading (students earn A, B, C or F) in internship/practicum/clinical experience courses, the only choice will be to award the grade of "F" when a student is making progress, but not finished the field hours.

The policy will be put into print for student advisors explaining the variable credit options.
