## Grade Estimates

During the regular session, grade estimates are available to all first-year students, upperclass students making a "D" or "F" and students who are not making satisfactory academic progress (all students with a cumulative GPA less than 2.0). Estimate grades are due to the Office of Registration <u>by noon on Monday of the sixth week of regularly scheduled classes</u> and are available to students and advisors in myLongwood as soon as they are posted.

Estimates are not recorded as part of the student's permanent academic record. They are, however, an important indicator of academic risk to students. This early warning should give the student time to improve academic performance where needed.

After discussion Sharon Menegoni offered to write up a proposal for grade estimates for fall and spring semester grade estimates.
