Current language:

Students who complete Calculus (MATH 261 or 267) are exempted from this goal.

Proposed language:

Students who complete Calculus (MATH 260, 261, or 267) are exempted from this goal.

ii. To change slightly the catalog policy on speaking intensive courses.

Current language:

Transfer courses do not satisfy speaking intensive requirements.

Proposed language:

Transfer courses do not *normally* satisfy speaking intensive requirements.

Rationale: Both the Petitions Committee & the General Education Committee believe that on occasion, with proper documentation, a student should be able to receive speaking intensive course credit for a transfer course. To date, however, because of the categorical nature of the current language, the Petitions Committee has felt unable to grant any student petition, even one with documentation, asking that a transfer course fulfill the speaking intensive requirement. Adding the word *normally* will make clear the Petition Committee's authority to grant a student's petition seeking speaking intensive credit for a transfer course, if the Committee believes the student's documentation and/or endorsement from the relevant Longwood department supports the petition.

iii. To modify current policy on students seeking a second degree as follows: Current policy with changes indicated:

Second Baccalaureate Degree: A student who has earned a baccalaureate degree from Longwood or any other accredited institution may earn a second baccalaureate degree by satisfying the following requirements:

- 1. Submit an undergraduate Application for Admission, a \$40.00 non-refundable application fee, and all official college transcripts directly to the Office of Admissions.
- 2. Submit a completed undergraduate Application for Degree to the Office of Registration, along with the appropriate diploma fee to the Office of Cashiering and Student Accounts. In order to complete the Application for Degree, the student must meet with the appropriate Department Chair. (Note: The admission process will not be completed until this application has been filed.)
- 3. Complete, at Longwood, at least 30 semester hours in a second-degree program beyond that work applied toward the first degree. All lower division general education

requirements are met by the first degree. Additional degree requirements are met by the first degree where applicable. all coursework required by the second program to earn the degree specified for that program. At least 30 hours for the second degree must be completed at Longwood.

- 4. All general education requirements and speaking and writing intensive course requirements are met by the first baccalaureate degree. Additional degree requirements are met by the first degree where applicable.
- **4.** 5. Maintain a minimum 2.0 grade point average cumulatively and in the major unless a higher minimum grade point average is specified for a particular major.
