2. Bring content for Middle School Licensure program in line with VA Department of Education regulations
3. Send BA option for the licensure programs to storage for streamlining. Other universities in Virginia offer only one degree option for degree programs leading to elementary and middle school licensure.

A. These program changes require no new courses. The changes in the science course requirements will require staffing adjustments in CHEM/PHYS that have already been addressed by that department.

Students pursuing the BS in Liberal Studies that includes a teacher licensure program will complete parts A-E. Students pursuing the BS or BA in Liberal Studies that does not include the teaching licensure program will complete parts A-D.
A. GENERAL EDUCATION - 40 credits ( 41 for BS or BA with minor)

Goal \#5. Math - 3 cr. - can be met with MATH121, which is required for the major. Middle School Math Concentrators are exempt from this goal by taking upper level math courses. Goal \#8. Contemporary Society - 3cr. - can be met with POSC150 which is required for the major. Goal \#12. SOCL320. Sociology of Education - 3 cr.
Goal \#13. May be met with PHIL308, PHIL315 or PHIL316-3 cr.
Goal \#15. Exempt, except for BS or BA with a minor - 1 cr.
NOTE: Courses for Goal 5 and 8 are counted in the Gen Ed total credits and are not counted in the major total credits. Goal \#15 is counted in General Education for BS/BA with a minor and in Professional Education, Part E below, for students on the Teacher Licensure Programs.

## B. ADDITIONAL DEGREE REQUIREMENTS - imbedded in the LS core

For students pursuing the BS with a teacher licensure option these courses are included in the major. Students pursuing the Liberal Studies major with a minor in an Arts and Sciences discipline may select either a BS or BA degree. The BA requires the addition of Modern Language at the 202 level to complete this category.
