**PLEASE NOTE:** Due to the COVID19 Pandemic, IACS has temporarily stopped performing in person site visits. The IACS Site Visit Program Coordinator, Dr. Anika Fields, has been working on setting up a Virtual Site Visit Program. Please be aware that even after the Virtual Site Visit Program begins, it may take many months before a visitor or site visit team (schools with a student enrollment of 7500 or more will have two visitors) becomes available for your center.

Once the visitor or team is in place, you will receive another memo from the IACS Office with the contact information so you can find a mutually convenient date for the visit to take place. If your application needs to be updated in any way prior to the visit, we will work with you to have that information in place and available for the visitor(s).

You will be receiving an invoice for the \$1,500.00 Site Visit Fee by an e-mail attachment. The Fee must be paid prior to the date of the visit.
