

## ***Honor and Judicial Process Survey Results 03-04***

Notes: Ratings are based on a five point scale where 1 = strongly disagree, and 5 = strongly agree. There was a significant difference in ratings depending on whether or not a student made a pre-hearing conference with the Director, thus ratings are broken out for all students, those who attended a pre-hearing conference, and those who did not.
