**TOPIC:** FPPM policies on Sabbaticals, Connections, and Grants.

The Committee on Faculty Development submitted changes to the policies in the FPPM last year regarding Sabbaticals, etc. The changes submitted inadvertently failed to change the wording of the FPPM in two locations that reflect the policy changes that were approved by the Senate last year.

<u>SUMMARY</u> OF NEW POLICY OR PROPOSED CHANGES OR DELETIONS TO AN **EXISTING POLICY** (Provide a brief list or statement describing the content of the policy or the proposed changes or deletions):

The 2016-2017 FPPM stated in several places that faculty members were <u>not eligible</u> to receive sabbaticals/connections/grants if he or she failed to turn in a report describing the outcome of previous leaves or grants.

The Senate last year approved a policy change that <u>correctly</u> appears on page 161, "Faculty members who fail to submit a written report will not be eligible to receive further grants/awards/leaves until all previous reports have been submitted, and must wait one year before applying again once the backlog reports are received."

Action required here: Change the text on page 162-163 (Section FF 2 d), and on page

247 (A 6) to reflect changes approved by the Faculty Senate last year.

(1) Pages 162-163 of the current 2017-2018 FPPM <u>incorrectly</u> states: "Faculty members who fail to submit a written report will not be eligible to receive future sabbatical or faculty connections leaves."

The above text should be changed to: "Faculty members who fail to submit a written report will not be eligible to receive future sabbatical or faculty connections leaves until all previous reports have been submitted, and must wait one year before applying again once the backlog reports are received."

(2) Page 247 <u>incorrectly</u> states: "Faculty members who fail to submit such a written report will not be eligible to receive future grants."

The above text should be changed to: "Faculty members who fail to submit a written report will not be eligible to receive future grants until all previous reports have been submitted, and must wait one year before applying again once the backlog reports are received."
