# **Course Catalog Description:**

**ENSC 490.** *Directed or Independent Study.* A directed project administered by qualified specialists in the department. By permission of instructor and must be approved by the head of the department. 1-12 credits. \*Fulfills General Education Goal 14.

#### **Textbook(s):**

Textbook(s) and/or supplemental readings, such as scientific journal articles, are generally required and will vary depending on the directed or independent study.

# **Course Objectives:**

This course is designed to develop skills and knowledge in an area of environmental science that is not supplied through current course offerings. Each student must determine more specific objectives for the directed or independent study in consultation with the instructor besides the ones written below.

- Describe and define key concepts of the special project.
- Analyze important problems as they relate to the special project.
- Demonstrate knowledge of various topics through experimentation and or tests.
- Create presentations/papers about fundamental aspects, and results of the special project.

#### **Class Schedule:**

The student and instructor will determine the specific schedule. It is expected that the student will engage in a sufficient number of "class hours" to meet university standards for each credit hour of enrollment.

# **Course Requirements:**

Students are expected to maintain the agreed upon schedule for the directed or independent study and to work diligently toward accomplishing the stated objectives. Assignments and/or tests will vary according to the nature and format of the directed or independent study.

## **Grading:**

The grade for the course will be determined by the instructor and criteria will vary according to the directed or independent study being conducted.
