Sabbatical proposals must come to the PVPAA's office, so a copy of a request for altered evaluation guidelines would accompany such a proposal. Item 1) makes that explicit. Item 3) had been requested by Faculty Senate Executive Committee, and it mirrors language drafted regarding

sabbaticals. Items 2) and 4) ensure that faculty who are considering a sabbatical, Connections, or other type of leave are aware of the need to include annual evaluation alterations as part of their proposal or discussion.
