We expect to bring II.R. to Exec, and then Senate, before the end of the 2015/16 academic year.

There are revisions to the purpose and duties of the committee as well as changes to the membership and college restrictions.

- The committee believes "intellectual property" is more appropriate language to describe the purview of duties than "copyrights and patents."
- Adding college affiliation restrictions to membership will better ensure that the committee represents a balanced and varied perspective on intellectual property from the sciences, social sciences, and humanities.
- The Director of the Office of Sponsored Programs has been added as a standing member, since this office is versed in intellectual property matters from the perspective of grant supported research and publication.
- The Dean of the Library, VP for Administration and Finance, and a designee from University
 Marketing and Communication are now ex-officio members, and represent three offices that
 typically receive questions related to intellectual property. The University Marketing and
 Communication designee has been added to reflect potential issues related to logos and
 trademarks.

K. LONGWOOD COMMITTEE ON COPYRIGHTS AND PATENTS <u>INTELLECTUAL PROPERTY</u>

- 1. Purpose and Duties: The responsibility of this committee is to consider promptly all reports of intellectual property referred to it by the Chief Administration and Finance and to determine whether the Chief Administration and Finance Officer review issues, questions or disputes pertaining to ownership of intellectual property rights involving possible ownership, or partial ownership, by the University, and to interpret the Intellectual Property Policy with respect to those issues. (See II.R.)
- **2. Membership:** 5 faculty members. and 1 administrator the Director of the Office of Sponsored Programs.
- **3.** Ex-Officio Members (non-voting): None Director of the Office of Sponsored Programs, Dean of the Library, Vice President for Administration and Finance, and a designee from University Marketing and Communications.
- 4. Tenure Restrictions: None
- 5. Departmental Restrictions: None
- **6. College Restrictions:** None Three faculty members from the Cook-Cole College of Arts and Sciences (one from mathematics or the natural Sciences; one from the social sciences; one from the humanities), one faculty member from the College of Business and Economics, one faculty members from the College of Education and Human Services.
- 7. Other restrictions: None
- **8. Term of Office:** 3-year staggered terms. May be reappointed for 1 additional term with a 6-year maximum.
- **9. Method of Selection:** Appointed by the Chief Academic Affairs Officer Provost and Vice President for Academic Affairs (PVPAA) (upon nomination by the Executive Committee of the Faculty Senate.)
- **10. Chair:** Appointed by the PVPAA.
- 11. Reporting Route: Chief Administration and Finance Officer Vice President for Administration and Finance, and, if necessary, Chief Academic Affairs Officer Provost and Vice President for Academic Affairs (PVPAA) (see II.R.II.A.1B.2).
