This semester it was concluded that the expanded membership (over 40 member) was not working. Beyond that, the discussion turned to how to make AAC more effective. The proposed changes are the result of that discussion.

SUMMARY OF NEW POLICY: The membership of the committee shall consist of all academic department chairs, the Director of Liberal studies and the Vice-President of Academic Affairs. All but the VPAA will be voting members. The name of the committee shall be changed to the Academic Chairs Council.

RATIONALE FOR THE POLICY: To make the committee a more effective policy advisor to the Faculty Senate and also to the VPAA

D. ACADEMIC AFFAIRS COMMITTEE ACADEMIC CHAIRS COUNCIL

- 1. Purpose and Duties: The Academic Affairs Committee Academic Chairs Council is an advisory committee to the Senate and, in this capacity, recommends policy on academic rules and regulations. In addition, the committee is an advisory body for the VPAA and serves as a valuable link in disseminating information between the academic administration and the departments. All matters pertaining to the academic well-being of the institution are within the purview of this committee.
- 2. Membership: Varies with the number of academic departments.
- 3. Ex-officio Members: All members of this committee are ex-officio, since they all serve by virtue of position. Voting members are the department chairs and the Dean of Longwood Library. Other members are the VPAA, the college deans, the Associate to the Vice President and Director of the Honors Program, the Dean of the College of Graduate and Professional Studies, and the Registrar. Membership shall consist of the department chair from each academic department and the Director of the Liberal Studies Program. The VPAA shall be a non-voting member of the committee; all other members shall have a vote.
